Do I Need a Trust?

<u>Bryan Palmer</u> looks at the ways trusts can help families and individuals achieve their financial planning goals.

"Trusts are often viewed as the most 'optional' part of an estate plan. But you will do yourself a disservice by not considering how this powerful estate planning tool can help you reach your goals. You should consider the following questions when deciding whether a trust is appropriate for you.

Q: Do I want to control who is responsible for managing my assets if I become incapacitated?

Without a trust or a power of attorney honored by all the financial institutions where you have assets, a probate court appoints a guardian to manage your estate when you are no longer able to do so. That process – which may be open to the public – gives the probate court ultimate control over who serves as your guardian." Read more...

Form I-9 Flexibilities Allowing Remote Review of Employment Documents Extended Through July 2023

DHS and ICE recently announced the extension of their guidance to allow employers to remotely verify Form I-9 information. Annie Grove looks at how to benefit from this extension.

"The U.S. Department of Homeland Security (DHS) and the U.S. Immigration and Customs Enforcement (ICE) announced on October 11, 2022, that their guidance on Form I-9 flexibilities will be extended until July 31, 2023.

The Form I-9 flexibilities – initially announced in March 2020 at the start of the COVID-19 pandemic – suspended the mandatory "in-person" review of documents when employees are hired. Instead, employers are permitted to examine documents remotely. Generally, employers must complete the inperson review of I-9 documentation by the third day of employment." Read more...
